INDICTMENT

126-GJ-052446B

The grand jurors of Pinal County, Arizona, accuse ANGEL HERNANDEZ-DIAZ, charging that in Pinal County, Arizona.

COUNT 1

On or about 03/04/2010, in or near Maricopa, Arizona, ANGEL HERNANDEZ-DIAZ while driving a motor vehicle, willfully fled and attempted to elude a pursuing official law enforcement vehicle which was being operated with proper emergency equipment, thereby committing Unlawful Flight, all in violation of A.R.S. §§28-622.01, 28-624(C), 13-610, 13-701, 13-702, 13-712, and 13-801, a class 5 felony.

COUNT 2

On or about 03/04/2010, in or near Maricopa, Arizona, ANGEL HERNANDEZ-DIAZ committed Aggravated Assault by assaulting [REDACTED] of AZ Department of Public Safety while using a deadly weapon or dangerous instrument, to wit: a gun, in violation of A.R.S. §§13-1204(A)(2), 13-1204, 13-1203(A)(2), 13-704, 13-610, 13-701, 13-702, 13-709.01, 13-712, and 13-801, a class 2 Dangerous felony. The State of Arizona alleges that Count 2 is a dangerous offense as it involves the discharge, use, or threatening exhibition of a deadly weapon or dangerous instrument, to wit: a gun.

COUNT 3

On or about 03/04/2010, in or near Maricopa, Arizona, ANGEL HERNANDEZ-DIAZ committed Theft of Means of Transportation by controlling another person's means of transportation with the intent to permanently deprive the person of the means of transportation, to wit: A Ford F-350 Truck belonging to [REDACTED], in violation of A.R.S. §§ 13-1814 (A)(1), 28-3304 (A)(3), 13-1801, 13-610, 13-701, 13-702, 13-712, and 13-801, a class 3 felony.

COUNT 4

On or about 03/04/2010, in or near Maricopa, Arizona, ANGEL HERNANDEZ-DIAZ committed Misconduct Involving a Weapon by knowingly possessing a deadly weapon, to wit: gun used in the commission of the crime alleged in Count 2, while being a prohibited possessor, in violation of A.R.S. §§13-3102(A)(4), 13-3102, 13-3101(A)(7)(E), 13-3101, 13-3105, 13-610, 13-701, 13-702, 13-712, and 13-801, a class 4 felony.

COUNT 5

On or about 03/04/2010, in or near Maricopa, Arizona, **ANGEL HERNANDEZ-DIAZ** committed Misconduct Involving a Weapon by knowingly possessing a deadly weapon, to wit: Beretta pistol, while being a prohibited possessor, in violation of A.R.S. §§13-3102(A)(4), 13-3102, 13-3101(A)(7)(E), 13-3101, 13-3105, 13-610, 13-701, 13-702, 13-712, and 13-801, a class 4 felony.

COUNT 6

On or about 03/04/2010, in or near Maricopa, Arizona, **ANGEL HERNANDEZ-DIAZ** committed Misconduct Involving a Weapon by knowingly possessing a deadly weapon, to wit: AK47 Rifle, while being a prohibited possessor, in violation of A.R.S. §§13-3102(A)(4), 13-3102, 13-3101(A)(7)(E), 13-3101, 13-3105, 13-610, 13-701, 13-702, 13-712, and 13-801, a class 4 felony.
