FINAL ORDER OF AUTOMATIC SUSPENSION

WHEREAS, the records of the State Board of Dentistry ("Board") reflect that Glenn H. Featherman, DMD ("Licensee") is the holder of a license to practice Dentistry, license no. DS-025882-L, in the Commonwealth of Pennsylvania;

WHEREAS, on December 31, 2013, upon consideration of a Petition for Automatic Suspension, the Board issued a Notice and Order of Automatic Suspension which automatically suspended Licensee's license to practice Dentistry under the authority of section 5.1 of the Dentistry Law, 63 P.S. §124.1;

WHEREAS, the Board has received no response to the Petition for Automatic Suspension and no request for hearing from Licensee;

NOW THEREFORE, the Board ORDERS that the license to practice Dentistry issued to Glenn H. Featherman, DMD, license no. DS-025882-L, shall be AUTOMATICALLY SUSPENDED under the authority of section 5.1 of the Dentistry Law, 63 P.S. §124.1 for at least ten years from the date of conviction.

The Board ORDERS that Licensee shall immediately CEASE practicing the profession.


IT IS FURTHER ORDERED that, within ten (10) days of the date of this Order, Licensee shall return his wall certificate, wallet card, and registration certificate by mailing them to:
