### **SYNOPSIS**

On 04/22/2015 at approximately 1635 hours, Brittney Griner and Glory Johnson committed assault by recklessly causing physical injuries to each other and committed disorderly conduct by engaging in mutual combat fighting behavior while at \$150 \text{N}\$ 133rd Dr, Goodyear, AZ 85395. These offenses are domestic violence offenses as Brittney and Glory are in an intimate relationship, engaged, and reside together.

### **NARRATIVE**

On 04/22/2015 at 1637 hours, I responded to a reported physical fight between two females at N 133rd Dr in Goodyear, AZ. The person reporting was Judy Johnson. Call information stated Judy's sister was physically fighting with her fiance. Further information stated Judy's second sister was also present along with another friend. She advised the two females were currently in the living room throwing items at each other. Prior to my arrival, Judy advised she was waiting outside with her sister's fiance.

Upon my arrival, I located Judy who was standing in the driveway who was talking on the phone. I could hear her advise the person she was on the phone with the police were on scene. I also observed a second female standing at the North end of the driveway.

I asked Judy to tell me what happened. Judy told me her sister, later identified as Glory Johnson, and her fiance, later identified as Brittney Griner, were fighting. Judy advised "We couldn't get them pulled apart" and stated it was, "Getting pretty heated". Judy stated she did not know what else to do, so she called police because she, "Did not want anyone to get hurt".

I then approached Brittney who was standing at the North end of the driveway and asked her what the argument was about. Brittney told me her fiance and she had been arguing everyday, verbally. Brittney said the two were having relationship issues. Brittney advised she had just purchased the house with her fiance, Glory. I asked Brittney if things just got out of control, and she nodded her head up and down.

Brittney stated her best friend Julio Trejo, her fiance Glory, Glory's sister Grace Johnson, and Judy Johnson, were all present at the home. Brittney said, "Only two of us were fighting. Everybody else, when we got into it, was trying to stop us". I asked Brittney if she was hurt, and needed the fire department. She told me she was not and stated she had a, "Tooth mark" on her hand. I looked at Brittney's middle finger on her right hand and observed a small puncture would on top of the finger. I could see the skin was broken and could see what appeared to be dark red blood inside of the wound.

On top of Brittney's right wrist, I observed a laceration. It was horizontal across her wrist on the top, next to the joint. It appeared the outer layer of skin had been removed and exposed was light red flesh of the second layer of skin. Brittney had a third laceration on top of her right pointer finger. The small laceration was red and it appeared the outer layer of skin had been removed. Red flesh was exposed on top of the middle knuckle, on the outer portion of her finger.

I asked Brittney how long she had been fighting with Glory. Brittney said she was arguing back and forth with Glory for a couple minutes. She stated she was physically fighting with Glory for between 4 and 6 minutes. She stated the entire argument lasted about 20 minutes. I asked Brittney how she came to get bit. Brittney said the fight started standing up, then Glory and she fell on top of each other onto the floor. Brittney stated she was pushing back, and her finger got in Glory's mouth. She stated her finger was there at the wrong place and the wrong time.

Brittney stated the two of them were in each other's faces. Brittney advised they were talking with their hands, back and fourth, and pointing at each other. Brittney told me she was, "Tired of hearing it" from Glory and put her hand in Glory's face, but did not hit or touch her. She demonstrated her action to me and placed her palm directly in front of her own face, about an inch away from her

face. Brittney told me she got, "A hand to the face" from Glory to get her out of her face, and the fight continued to the living room where things exploded. She stated Glory and she were never really separated from the bedroom argument, and the fight continued in the hallway. Brittney advised this was a results of weeks of stress including buying a house, planning a wedding, and their relationship.

I asked Brittney if anything was broken inside of the home. She advised a ceramic glass dog bowl was broken. Brittney admitted to throwing the dog bowl at the wall during the argument, and it broke.

I asked Brittney if anyone else was inside the house when this happened and she advised all five people were present. Brittney stated she was talking with Glory in their master bedroom and said Glory's sister came into the room to try and help mediate. Brittney said they tried to get through it, but things escalated to Glory pushing her face with her hand and, "It turned into a fight. Broke up. We kept arguing, mouthing back and forth, clashed again, separated us, clashed again, separated us, and here we are now".

After speaking with Brittney, I then went back to the other side of the driveway where Judy was standing. I saw Sgt. Brilhart was speaking with Glory and Julio. I saw Julio had a large bleed laceration on the right side of his neck. Grace was standing next to the front door. Please see Sgt. Brilhart's supplement for further. I asked Judy to tell me what happened. Judy told me Brittney and Glory were fighting and she had to call police. I asked Judy what Julio's involvement was. Judy said Julio was trying to get Glory and Brittney to stop fighting.

I told Judy, Brittney had been bitten and had marks all over her hand. I asked how that happened. Judy told me, "It was crazy, we were trying to pull them apart, and I don't know who bit who, or what". I asked Judy who started the fight. Judy told me she was not sure. Judy advised Brittney and Glory were in the master bedroom talking, but arguing. She advised she went to the bedroom to see what was going on. Judy said Glory and Brittney got in each other's faces, and Brittney had her hand up.

Judy initially told me one of the two had their hand in the other's face but she did not know who. Judy then said, "Actually, Brittney had her hand in my sister's (Glory) face" and she advised Glory knocked Brittney's hand out of her own face. After Glory knocked Brittney's hand out of her face, she stated that the two then separated and went towards the living room. Judy advised Brittney then walked past Glory and pushed her, and they began fighting again at which point she tried to break up the fight.

After speaking with Judy, I spoke with Sgt Brilhart, who had gathered a statement from Glory. I then looked at Glory. I could see a laceration above her right side of her lip. The outer layer of skin was removed, and the pink, fleshy second layer of skin was exposed. She advised the injury was from Brittney. Glory was asked if she needed medical attention and she refused. Sgt. Brilhart also advised Julio, who was injured, refused to comment on what happened during the argument, and did not desire prosecution. His injury was photographed. Neither Brittney nor Glory desired prosecution against one another.

Based on the totality of the circumstances, it appeared mutual combat had occurred between Glory and Brittney who both engaged in fighting behavior, recklessly causing physical injury to one another. At 1708 hours, they were placed under arrest for assault and disorderly conduct. Ofc. Braughton who was on scene, conducted a female search on both suspects. They were both fingerprinted and photographed. Both Brittney and Glory were provided victims rights as well as a copy of the citation that was placed in their respective impounded property bags. They were later transported to the Fourth Ave Jail without incident.

Nineteen digital photographs and three audio recordings were downloaded to the Goodyear Police DIMS system as evidence.

This case is cleared by arrest.

NARRATIVE:

On 04/22/2015 at about 1647 hours I responded to the location of N. 133rd Dr., Goodyear, AZ in reference to a domestic incident. When I arrived on scene I was asked by OFC. Ross to stand by with a female party named Brittney Griner in the front yard while he continued his investigation. Please refer to OFC. Ross's original report for further information.

Once OFC. Ross affected two arrests on both Brittney Griner and Glory Johnson I assisted by transporting Griner back to our main police station processing area located at 1111 S. Litchfield Rd., Goodyear. I assisted OFC. Ross by fingerprinting and photographing both subjects. I also conducted a female search on both subjects. Glory Johnson and Brittney Griner had five total pieces of jewelry they wanted released to Grace Johnson, Glory's sister. I handed these five items which included three rings, two stud earrings, and a belly button ring to Grace Johnson in a property bag in front of the main police station at 1819 hours.

Next I assisted by transporting Griner to 4th Avenue Jail in Phoenix. I took over custody of the second subject Glory Johnson while in the intake booking area at 4th Avevue Jail and stayed to book both subjects into the acceptance area in the jail. Both were booked on their respective domestic violence charges without incident. It should be noted that while in my custody both Griner and Johnson were very cooperative.

This concludes my involvement in this case.

The laceration appeared to be consistent with being scratched by fingernails or another like I asked Julio if he need any medical attention for the scratch and he stated "no."

Julio what his relationship was with Glory and Brittney and he stated that he was Brittney's best friend and friends with I asked Julio if he lived in the residence and he replied "no, I live in Phoenix." I asked Julio if he has every lived with or had a ship with anyone on scene and he stated "no."

Julio to tell me what happened and he stated "no offense sir, but I would rather not speak about what happened." I informed it was his right to do so if he chose not to speak with me. I asked him if he wanted to aid in prosecution for who scratched his he stated "no." I informed Julio that we still needed his information and needed to photograph his injuries to document ng in case he changed his mind. Julio stated he understood and allowed Officer Ross to photograph his neck.

g to Glory Johnson:

oke to Glory about what had happened. As I began to speak to her I observed a fresh laceration on the right side of her . The laceration appeared to be fresh and was bleeding. I asked Glory if she need any medical attention and she stated "no." Glory again what occurred and she related the following information to me.

ted that Brittney, she, and her two sisters moved into the residence two days ago. Glory stated that her and Brittney are a wedding as Brittney is her fiance. Glory stated that Brittney "disrespected" her while inside the house. I asked Glory how 'disrespected" her and she stated she forgot and could not remember.

tinued to say that after the "disrespect" Brittney got "in her face" stating that Brittney was inches from Glory's face as they ing. Glory stated that she was not comfortable with Brittney being "in her face" and pushed her aside to create some o she could go by Brittney and speak to her sister.

ed that after she went by Brittney she thought things were settling down as she began to speak to her sister. Glory stated as beaking to her sister, she was pushed in the back of the head by Brittney. Glory stated that she turned around and the ltercation had begun.

ed her sisters and Julio were trying to hold each of them back and attempting to separate the two. Glory stated she was wor who scratched her lip. Glory stated she did not remember anything else as the event unfolded quickly.

Led Officer Ross what Glory had told me and stayed on scene until Officer Ross, Irvine, and Rose placed both Brittney and under arrest.
